1.7 **Bid Security Declaration:** Bidder shall upload scanned copy of Undertaking for Bid Security Declaration as per **Annexure-12 of RFP** at the time of online bid submission. If Undertaking for Tender Security Declaration is not submitted or is not in prescribed format then such bids shall be considered ineligible and summarily rejected.

1.8 Minimum Eligibility Criteria

- 1.8.1 Annual Average Turnover: Bidders shall have a minimum annual average gross turnover of Rs. 30.77 Lakhs from advertisement sector(s) in last 3 (three) i.e. 2018-19, 2019-20 & 2020-21 audited financial statements (if applicable) certified by Chartered Accountant with stamp & signature (i.e. gross aggregate turnover of Rs. 92.31 Lakhs in the last three financial years stated above).
- **1.8.2** In addition to above, the tenderer should have executed at least one advertisement work in Metro trains/ Railways also.

operations "train set-days" in a month (provided from Operations/Rolling Stock Department of UPMRC) whichever is lesser. However, since the payment is to be done in advance on quarterly basis, hence advance payment will be required to be done for 4 train sets for a quarter and any adjustments in license fee (if needed) on actual operations basis will be made in the next installment on the basis of actual wrapped "train set-days" in preceding quarter.

- 3.4) All Metro Trains as detailed in Annexure-I shall be handed over for advertisements within 10 days from the date of receipt of Interest Free Security Deposit (IFSD) full payment as stipulated in Letter of Acceptance. The License Fee shall commence immediately after expiry of fitment period of 30 days from the date of the first handing over of trains by UPMRC i.e 31st day of first-handing of trains on N-S Corridor for advertisements.
- 3.5) Along with License Fee, Licensee shall also pay other dues like GST, statutory dues/liabilities, electricity charges, damage/penal charges, pending arrears, etc. as applicable. The present rate of GST is 18%. Any further revision in rates of GST will be applicable from time to time.
- 3.6) The Licensee should preferably make the payments of advance License fee payable on quarterly basis to UPMRC by E-mode i.e. RTGS/NEFT for credit of account of UPMRC Ltd. after taking prior Approval of UPMRC and duly complying with the laid down procedure (Annexure-IV) of UPMRC in this regard.
- 3.7) The trains of Line 1 in depot shall be handed over after due acknowledgment from the concerned depot in-charge as per the prescribed pro-forma Performa given in Annexure-VI. If the licensee fails to take over the trains within 10 days from the date of making payment as per LOA & on receipt of the intimation of handing over by UPMRC, the trains shall be treated as deemed to be handed over from 11th day of receipt of LOA payments by UPMRC. The License fee for coaches/train sets handed over subsequently shall commence immediately after the date of handing over of Trains, without consideration of any fitment period.
- 3.9) The configuration of each train set may be modified by UPMRC at any stage on line 1. UPMRC may induct additional train sets in the given line or withdraw any train set from the service in a particular line, without giving any prior intimation to the Licensee. However, there shall not be any reduction/increase modification in the monthly license fee, except for the provision of increase in license fees for holding beyond 80 car coaches on N-S Corridor as mentioned below.
- 3.10) The amount of the license fee payable to UPMRC shall remain valid up to 80 number of car coaches holding in Line 1 for inside train advertising scope &
